I have a few ideas for prospective action, short of actual litigation. If you have not yet, you should request a copy of Nano-Tech's Storm Water Pollution Prevention Plan, available from both the Town and from DEC. I would also FOIL all documents showing their compliance with this plan - if possible, try to speak to a DEC engineer named Carol Lamb LaFay. I am enclosing, for your reference, a notice of intent to sue that I once filed against a company that was violating its SWMPP. Filing the notice letter achieved the purpose of punishing the offender without litigation (it prompted DEC to take appropriate action.

You could also consider a referendum campaign under the Town law for various things that could affect the project. You might also consider having the gazebo dedicated to the heroic men and women of the town of Guilderland who have fought in the wars in Afghanistan and Iraq - since section 72 -a of the Town Law authorizes the town to construct monuments dedicated to the armed forces, and such monuments should obviously not be subjected to water pollution.
